

We managed to recover from the lockdown that impacted the first part of this financial year and continued to run all our programs and support girls and young women in need, in line with our COVID Safe Plans. Our Business Continuity Plans were updated as needed and have been a good foundation for us in bouncing back from the challenges of delivering services in a COVID affected environment.

Incredibly, we also completed Accreditation achieving 100% of the requirements for ASES accreditation, it was a true team effort over a long period of time.

I have to recognise how difficult the last year has been and how well the Manager, Vivian Stavis, the amazing staff and girls we care for have dealt with this, with support from the Management Committee. I want to congratulate and thank you all, your dedication and commitment to our girl's wellbeing is endless and your talent, commitment and passion have ensured that our girls have received vital care and support.

Despite the unsettling environment due to COVID, we still met the needs of the girls and young women we serve.

Our major contracts all renewed successfully, and we continued to work in partnership with Youth Off The Streets (YOTS) and with Department of Communities and Justice (DCJ) to deliver homelessness and early intervention programs to girls and young women throughout Sydney.

We were able to obtain funding through grants and I want to acknowledge the efforts of Dr Marnie Graham-Briggs for her grant writing support to secure funds to make necessary updates and changes at Lillian's.

Thank you to our fundraising committee headed by Kylie Evans and her amazing team of supporters who through their efforts have opened up opportunities for the girls that were otherwise not available. At Lillian's,
"We believe all girls,

regardless of the disadvantage they face, deserve the opportunity to thrive." We are delivering on this promise and our hearts are full, with the many stories of our girls reconnecting with their families after months of separation, or re-engaging back at school after months of not attending, getting permanent jobs and permanent housing so they are in a position to determine their futures. The list goes on.

The part we play is even more important in the current times where mental health issues are on the rise and where there is so much uncertainty.

2021/2022 has been another difficult year working through the impacts of the pandemic and although there is an increasing need for our services from vulnerable young women who have been significantly impacted by COVID emotionally and financially, there have also been many highlights.



We have worked collaboratively to navigate the COVID outbreak in NSW and this has been a challenge for residents, staff and the sector alike however, staff have worked tirelessly to continue to focus on providing optimum service delivery.

We received many referrals for both accommodation and outreach case management supporting 88 young women. We provided 20 accommodation stays at Lillian's and provided an outreach case management service to 68 young women. Our ongoing partnerships ensured that we received the referrals required to achieve the numbers needed for our service agreement.

Our partnership with Youth off the Streets (YOTS), went from strength to strength moving from a Joint Working Agreement (JWA) to a Subcontract Agreement, with YOTS providing support when needed, working collaboratively to support each other and the girls and young women of Lillian's.

Our partnership with Good Shepherd continued with phone counselling being provided during the lockdowns and then continuing to face to face once the lockdowns ended.

As a staff team we attended many meetings where we sustained partnerships and remained informed of policy and other changes.

As always, Lillian's staff attended ASU meetings and were part of the paid DV leave campaign, where the Management Committee have approved and implemented 10 days paid DV leave for staff.

Lillian's also participated in a video for accreditation filmed by the industry partnership to help other services understand our experience of accreditation.

We supported 4 students, Social Work and Diploma Youth Work and Community Services to complete their work placements at Lillian's, who have all moved into paid roles within our sector.

Thank you to Kylie Evans, our chief fundraising cheerleader who organised a comedy night at Balmain Townhall and Christmas fundraiser at Aqua Luna. Without these fundraisers, many house outings and workshops wouldn't be possible, not to mention the volume of Christmas presents the girls received, so thank you to Kylie and all the amazing people who volunteered their time and to everyone who attended to make both nights the success that they were!

Staff, Management Committee, volunteers and students have all worked tirelessly, cohesively and collectively to achieve all that we have this year and I'm so proud to have you all as my colleagues. I am so grateful for the abundant talent, generosity, and skill you breathe through Lillian's, and for all you do in contributing to significant growth and change amongst the mighty, resilient girls and young women we work alongside.

And to our community – our wonderful, generous donors and service partners – thank you for your continued support and working with Lillian's to do what we do!

### Lillian's Girls Achievements

Despite being in lockdown, July - October, the girls had been amazing during this very difficult and uncertain time transitioning to online schooling seamlessly and with minimal difficulty, respecting the lockdown laws and doing the right thing. We had a few with the lockdown blues on occasion, but had been able to bring them around discussing self-care and coping strategies.

Once lockdown ended, <u>the girls were unstoppable</u>. They motivate and humble us daily and are the reason we keep working as hard as we do, and their achievements have been inspiring and extraordinary!

The girls' achievements include:

- 3 residents completed their HSC exams!!
- 2 residents were approved the YOTS scholarship.
- Swimming lessons were organised for 2 residents, and they learnt to swim.
- They completed an eight-week self-defence workshop called 'KYUP' and had a wonderful graduation where they performed the skills they had learnt and received certificates of completion, this was an empowering and bonding experience for the girls.
- The residents completed music workshops with Heaps Decent.
   They enjoyed working collaboratively to create their own tunes and flourishing their creativity.

- Photographic Exhibition Our volunteer Jenna organised for the girls to be involved in a photographic exhibition to fundraise for Lillian's that was inclusive of them. Each girl was given a camera with funds raised for the project and the girls had taken photos of things that inspired them in nature and their surroundings, they harnessed their creativity through the curation of their photographs for the exhibition. The completed works were displayed at Nest Creative Space. The exhibition was a huge success and are incredibly proud of their efforts.
- 2 semi-independent residents secured full-time employment, in Hospitality and in a Business Traineeship.
- 1 resident came first in Year 11 Advanced English, second in Biology and Maths.
- · Completion of Certificate III in Nursing
- RSA and RCG Course completion
- Re-engagement to school and maintaining attendance
- 3 girls secured part-time work in Hospitality.
- FACS scholarship applications were submitted and approved for most residents.
- We celebrated 15th x3, 16th x4, 17th x4 and 18th x1 birthdays and had celebrations here at Lillian's for them.
- Management of mental health, and personal growth in this area

12 girls moved out of Lillian's this year. They either moved into independent living/transitional housing, the private rental market or back into the family home.

We had 2 girls transition into Lillian's transitional properties, 2 into other transitional housing provided by other services, 2 moved into private rental, 3 moved back into the family home and 3 exited to other refuges.

### House Outings & Workshops

House outings and workshops are provided to build the emotional capacity of the girls that live at Lillian's and an opportunity to form attachments and bond with each other through shared experiences.

Although we started the financial year in a lockdown, 2021/2022 ended up being exciting and busy with many workshops and house outings programmed for our girls.


During lockdown, we had an extra staff member on during the day which was an enormous support for the girls, especially during the home schooling period. During the school holidays, we had prepared a holiday programme to keep the girls entertained and engaged. These activities included self-care activities (facials, nail painting) as well as painting, beading and tie dyeing.

Once lockdown ended, we went into full swing wasting no time organising house outings; These include:

- 2 day holiday to Avoca Beach, the girls fed alpacas and learnt to surf
- Delta Goodrem concert at Luna Park
- Shopping in the City and lunch
- Luna Park for HALLOSCREAM
- Easter Sunday High Tea at Lillian's
- Christmas Day Breakfast and Lunch at Lillian's
- Theatre Backwards Broadway show. They loved it!
- Balmain Wharf to see the Harbour Bridge VIVID lights.
- VIVID Cruise

- · Movies and dinner in Newtown
- Ice skating disco
- Makeup workshop

### Strategic Direction 2019 - 2024

As per our Strategic Plan 2019 - 2024, we worked well towards our Strategic Priorities of:

- 1. Quality Experiences for girls and young women
- 2. Maintain a Thriving Organisation in a time of change
- 3. Collaborative Partnerships and Sustainability.



### Strategic Outcome 1: Quality Experiences for Girls and Young Women

Despite the COVID-19 restrictions, we are constantly improving our service delivery to ensure girls have quality experiences. Girls had workshops on self-care where they learnt how to make facial scrubs and hand moisturizers. Many of the girls now engage in various self-care activities including walking exercises for their overall wellbeing. Although there had been no outings earlier in the financial year due to the pandemic, group indoor activities such as movies, dinner, and game night are constantly arranged to increase the resident's sense of belonging and creating memories through quality, fun experiences.

### Strategic Outcome 2: Maintain a thriving organisation in a time of change

Over the year we have lost and acquired some exemplar staff, who are competent, strong, capable and valued. This is evident by staff retention and staff commitment to Lillian's. To date, staff have been provided many opportunities to improve and strengthen their work practice, capacity and capabilities by attending various training workshops, monthly supervision, staff meetings and team building dinners. We conducted an evaluation on staff, students, volunteers and the Management Committee and the results were very positive. Despite the constant changes in restrictions and public health order, our team has been very supportive to one another in this difficult time, as have also remained committed to supporting the young girls.

### Strategic Outcome 3: Collaborative Partnerships and Sustainability

Effective relationships with key stakeholders including government, housing providers, sector peaks, researchers and advocacy groups have been sustained. Lillian's is actively involved with Yfoundations (Youth sector peak), DVNSW and Homelessness NSW, We have an existing MOU with Good Shepherd and Metro Housing who we work closely with to support our residents with counselling and in transitional housing. We have partnered with KYUP Project, Secure Base Solutions, Yoga Foundation and SBS to provide amazing opportunities for the residents. We also work closely with DCJ with referrals received in a casework capacity. We have been involved in many research projects, the most recent being on working effectively with young people coming out of Juvenile Justice (JJ) and forced marriage another, as well as the HYAP evaluation and an inquiry into Child protection conducted by Yfoundations.

### Residents Experiences MEET MINA

this my name is Mina, I'm 16 years old and have been at Lillian's for 9 months now. Growing up 1 was raised by my dad as a single parent with an absent mother, my parents met and were actually living in a refuge while 1 was born.

I faced a lot of challenges growing up without my mother, especially as I started to get older.

My father was an alcoholic and while he did try, he was also struggling with a lot of his own issues which unfortunately resulted in me experiencing a lot of abuse throughout my childhood.

Before coming to Lillian's I had been staying in crisis accommodation for 6 months, where I continued to struggle with my own addictions.

I remember very clearly my first intake interview at Lillian's. Having had bad experiences with other refuges, my hopes for Lillian's weren't very high. At the time I had no intentions to stop drinking, until I met Laura, Laura had given me an ultimatum. I needed to make a choice: alcohol or secure accommodation. In the car ride home my mind was set on alcohol, when I got home I did some research. I watched every video on the website at least 3 times and I guess something inside switched that day. I decided to go back for dinner, I just remember how sweet the residents were, the atmosphere and energy of the house was the first time I had truly felt happy to be sober in a year. I decided that night that this is where I needed to be, I didn't know at the time that that I had probably just made one of the best choices I had ever made for myself.

In the end 1 made the decision to stop drinking, not only for Lillian's but more importantly for myself. I am now 9 months sober and 1 probably wouldn't have been able to do it without Lillian's. My sobriety is now something that I am really proud of.

I know that I would probably be on a completely different path in life if I hadn't chosen Lillian's and for that I am so incredibly grateful for this service.

To me Lillian's is definitely more than just a refuge, it is the first place I've ever lived in were I feel safe. It's the first place I've lived in where I'm actually excited to come home everyday.

Lillian's feels more like a home than a refuge. One of those fun homes with those cool mums that every friend is jealous of. It's somewhere where I feel like I can truly be myself.

I've learned so much while living here, I've learned that it's okay to be vulnerable and that it's okay to admit that your eyes aren't actually sweaty, you're just crying.

There's still a lot of things that I'm working on like opening up to people more, and how to change the toilet paper.

But it feels a lot easier knowing that I have so much support behind me. I am so grateful to Lillian's for everything that they've done for me and for that I have to say thank you.

### Residents Experiences MEET SKY

# CCCCCCCCCC

Hi my name's Sky, I'm seventeen years old and have been with Lillians since May 2021 (approximately 18 months). As of now, I'm finishing off my HSC exams and am preparing to move into transitional housing in early November. Depending on when the AGM is taking place, this may have already happened.

To start, I'd like to say that I came here due to challenging circumstances and events, however, the intention of this speech is not to dwell on the past, it is to talk about how Lillians has changed my life.

When I first came to the refuge, I didn't know what to expect. Despite the bad reputation people had told me about refuges, I was determined and desperate to find somewhere to stay. My biggest concern at the time was that I needed somewhere safe to live so that I could focus on my studies and finish high school.

After my intake interview and my first dinner here, I knew this was the place for me. The dinner was questionable...(breakfast for dinner), but it was ultimately the people that tied my heart to this place.

In the first year of living here my life changed in ways that I couldn't ever have imagined. From learning to be more independent, to engaging in activities I wouldn't have normally. I was slowly drawn out of my shell and I saw my reality shift before my eyes. There had been many instances where I had woken up in my room in the morning and had been filled with a sense of contentment and disbelief towards how calm my everyday life was.

Whilst living here, I don't think there's ever been a dull moment, Lillians has always been filled with energy and life. From workers to residents, to volunteers and students, I've learnt from and have grown to love many. Life wasn't entirely easy, especially during covid when we were all in lockdown, but despite challenges, it was a major time of growth and I'm grateful to have spent it with the people I did.

I think the hardest time of my stay here was during the new year period when many people had been moving out at around the same time. When you spend that much time with people and build those connections and then those people suddenly leave it feels as if your life is falling apart. I was able to feel this deep level of pain because it was connected to immense love.

Moving into 2022 I was suddenly the oldest resident. As most of the people before me had been living here for quite a long time, it felt strange and it took time to adjust. While my first year here broke down and transformed my reality, my second years main focus has been and is to let go and allow myself to flow. In the past I was very much in a survival mindset, doing whatever I must to get by in this world.

Now, I don't stress over the things I used to and I have a deep inner-knowing that life will continue to change and grow no matter what happens. I'm eternally grateful for the support I've received here, through this support I've been able to take down barriers and have taken the time to know myself better and what it is I want to do in my life after this stage.

The non-judgemental support I've received has allowed me to be honest with myself and others so that I can be more authentic in the world and do what I truly love to do. It is within these moments that I am grateful to be here and alive.

Looking into the future, my wish is to build a career in music and in the arts. I don't know where this will take me but I want be courageous and take this chance.

In transitional, I will be living with one of my closest friends and the timing of this all happening has been perfect, thank you. While in transitional I want to create and form deeper bonds with those around me. I also wish to continue growing as an individual. I will continue working during this time but I'd like to find a new job, a job where I'm still working with other people, but is more relaxed and creative. I also hope that this job will pay me more than my current lol. During this time I will also be engaging in courses that support me in playing and producing music.

My goal for 2023 is to have created and released an album that heals and inspires those that listen to it. I will also continue to write as it has proven itself to be quite transformative. I could go on about my dreams and upcoming life for 2023 but I will leave it here.

Lastly, I would like to give one more thanks to Lillian's and all of those who continue to support the organisation.

## Residents Experiences MEET STEPH

Life leads every individual into unique circumstances, and the individual becomes shaped by these experiences as they grow. In my case, I grew up in a culture, where domestic conflict is hidden, yet so rampant in most households. I was a strong-headed and creative girl, but at home I was constantly surveilled, contained and controlled. I left my home when I was 16 after an explosive incident, which at the time seemed spontaneous, but truly it was a culmination of years of abuse and generational discourse.

While leaving home was the safest option for me, I felt lost in my newfound freedom and responsibility. I was overwhelmed with guilt and began to fall between feelings of extreme emotion, and sought to numb it with newfound distractions and substances.

However, a couple months later, Lillians took me in and helped to guide me through my teenhood. While I lived in the refuge, I made close friends with the other girls, and always felt a network of support around me. I was able to find a new home.

Lillian's supported me in numerous ways; teaching me essential life skills such as cooking, cleaning, managing my finances, and dealing with tedious paperwork. Lillian's also helped me shape my ethics and morals, and helped me to become a more kind and empathic person. My caseworkers were constantly by my side, cheering me on, even though I was rebellious and difficult to handle at times.

I felt an abundance of joy and the memories of holiday trips away to Glenworth valley, Christmas mornings and lockdown lunacy are ones that I hold dear to my heart. 6 months after I moved into the refuge, we agreed it was time for me to move on into their transitional housing program. It was an exciting and emotional time for me. I would no longer be in the constant company of the friends I had found.

Once again I felt lost, and I decided that instead of seeking a stable form of support, I would rebel once again, and seek comfort in my boyfriend at the time. Obviously that didn't work out, and there were consequences for my actions. I ended up flunking my exams, and losing the trust of those that were there for me most.

But despite that all, Lillian's still stood by me. After some reprimanding and a little more therapy, I was back on track and we decided to pursue a creative future for myself and enrolled into a fashion course at TAFE.

Two years on, I'm now working full-time in hospitality, working on fashion as a model and stylist on the side and looking for a private rental property to move out into.

You cannot see where life will truly take you, and I know that if my 16 year old self saw me now, she would be in disbelief of the progress we made through the support of the Lillian Howell Project.



### Financial Overview TREASURER'S REPORT

The financial position of Lillian Howell Project Inc remained strong in fiscal year 2022 despite the significant reduction in extraordinary COVID-19 related government stimulus.

Lillian's achieved this through prudent management of expenses as well as using the strong balance sheet for capital expenditure to boost productivity.

After a most challenging year, the current financial position and reserves of Lillian Howell Project Inc continue to be strong. All projects and grants were fully expended, and all legal accruals and entitlements were provided for.

In 2021/2022, Lillian's received HYAP funding of \$628,562 via our Subcontract arrangement from Youth off The Streets through Department of Communities and Justice (DCJ). They show that we experienced an operating loss of \$76,000 on funding from DCJ. This was attributable to an increase in staffing expenses with our staffing expenses being \$623,000 which is 99% of our overall budget, the staffing expenses are necessary as it's best practice to staff the refuge accordingly.

We continued in our efforts to fundraise through our Give Now donations page and the support of Lillian's Fundraising Committee led by Kylie Evans and supporters where we secured \$105,241 in donations. Through all this effort and support, Lillian's total revenue for this financial year was \$197,522.

We received many monetary donations and were fortunate enough to be granted funded projects, these include:

- Social Sector Support Fund
  - \$30,000 implementing SharePoint (Microsoft office) to be able to work from home and hard wiring the internet
- Powering Communities Grant \$6000 to upgrade the lighting and replace old air conditioning unit.
- Building Communities Grant \$76,000 to install solar panels replace the hot water system and replace the windows to double glaze.
- Inner West Council \$5000 for a Yoga Workshop
- Lonergan Foundation \$50,000 to complete the full installation of double-glazed windows at Lillian's.

So, as I reflect on another year, I am aware of how fortunate we are to enjoy the kind of governance you only get from an experienced, skilled and effective Management Committee and I recognise the huge value that we derive from our even more experienced, skilled and effective staff team led by our Manager Vivian Stavis. Thank you for your leadership and continued contribution to the amazing work of Lillian's.

The equity position of Lillian's is sound in absolute terms, as it represents one year of ordinary services expenses, which the management committee considers prudent for an organisation of Lillian's type. The principal activities of the association during the financial year were: The provision of a specialist Homelessness service providing medium to long-term 24 hour supported accommodation for young women and girls 13 - 17 years, that is trauma informed, reparative and empowering. As well as providing a safe and secure setting, Lillian's builds the capacity of the girls and young women and supports them in their transition to independent living.

#### Service approach includes:

- Providing intensive responses for clients with complex needs through intensive, multi-disciplinary support to girls and young women at risk of chronic homelessness as well as assertive outreach

#### Report on the Financial Report

I have audited the accompanying financial report, being a special purpose financial report, of Lillian Howell Project Incorporated (the "Association"), which comprises the Committee's Report, Statement by Members of the Committee, Income and Expenditure Statement, Balance Sheet, notes comprising a summary of significant accounting policies and other explanatory notes for the financial year ended 30 June 2022.

#### Committee's Responsibility for the Financial Report

The committee of Lillian Howell Project Incorporated, are responsible for the preparation of the financial report and have determined that the basis of preparation described in Note 1, is appropriate to meet the requirements of the Associations Incorporation Act of New South Wales 2009 and is appropriate to meet the needs of the members. These additional procedures included obtaining an understanding of the internal control structure for fundraising appeal activities and examination, on a test basis, of evidence supporting compliance with the accounting and associated record keeping requirements for fundraising appeal activities pursuant to the Charitable Fundraising Act 1991 and Regulations.
